Provenance:	Collection of the artist; almost certainly passed to the artist's
riovenance.	children; possibly the collection of Luis Francisco de Benavides Carrillo de Toledo, Marquis of Caracena (1608 – 1668); probably purchased by Juan Gaspar Enríquez Alonso de Cabrera, Duque de Medina de Rioseco and 10th Almirante de Castilla from the latter's sale before 1671; recorded in his inventory of 1691 (no. 326); thence by descent to Juan Tomás Enríquez de Cabrera, 11th Almirante de Castilla (1646-1705); purchased by Holy Roman Emperor Charles VI and transferred to Vienna, documented in the Newly Arranged Inventory of the Imperial Paintings Gallery in the Stallburg, Vienna (i66) in 1720 and in subsequent inventories of the Habsburg Imperial collections; transferred into Austrian state control at the fall of the Habsburg Austro-Hungarian empire in 1918. Note that this object has complete provenance for the years
